The Cinnamon armchair marks the first collaboration between Molteni&C and the Japanese designer Naoto Fukasawa. A masterpiece, that seamlessly blends form, function, and comfort. Cinnamon has an apparently simple but technically complex shape: the structure is characterized by a rounded line, essentially a simple U-shaped base that follows the entire perimeter. The bulbous central seat is completed by a removable cushion that has been designed for maximum comfort. Aesthetically harmonious, the armchair's stitches are masterfully hidden, leaving free expression to its sophisticated look. Crafted with meticulous attention to detail, it is upholstered with two elastic jersey fabrics specially made for the project that beautifully adapt to its rounded shape. Available in a range of 21 fabrics, each one adding a unique touch of elegance. From textural tones to shades of grey or ivory to warmer nuanced hues such as ochre. Cinnamon becomes an iconic design piece with great personality, created to be used with versatility in a multitude of contexts, such as the living room, bedroom, study, or any other space where comfort and style are a must. Its enveloping and sinuous shape offers an exceptionally comfortable and inviting feel and its unmistakable anthropomorphic references give it a distinctly playful personality, making it the perfect spot to curl up with a good book or simply unwind after a long day. 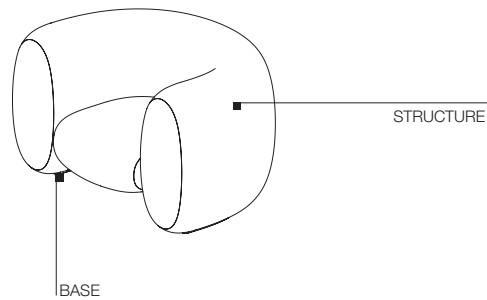

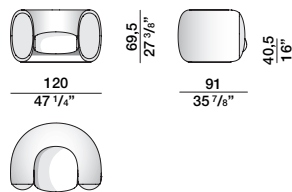
